



Terms & Conditions

Please read the following terms and conditions carefully before enrolling in the Reactive Dog Workshop ("the Class" or "the Workshop"). These terms and conditions outline the agreement between you (the "Participant") and Leader Of The Pack ("the training organization" or "we" or "us"). By enrolling in the Class, you acknowledge and agree to comply with the following terms and conditions:

1. Workshop Description:
 - a. The Reactive Dog Workshop is designed to provide education, training, and support to dog owners whose dogs display reactive behavior towards other dogs or stimuli.
 - b. The workshop aims to provide strategies, techniques, and guidance to help manage and modify reactive behavior in dogs.
 - c. The reactive dog training group Class is open to dog owners who have dogs displaying reactive behavior towards other dogs, people, or specific triggers.

2. Workshop Content:
 - a. The Workshop content is provided to the Participants so that they may practice and develop the skills under the watchful eye of the training organization to resolve their dog's reactive behavior over time.
 - b. The information and techniques shared in the Workshop are intended to assist Participants in managing and diminishing reactive behavior in their dogs but do not guarantee the complete elimination of reactivity upon immediate completion of the Class.

3. Participant Responsibilities:
 - a. Participants must ensure that their dog is up-to-date on all required vaccinations and in good health and physical condition.
 - b. Participants must handle their dogs responsibly and maintain control of them at all times during the Class.
 - c. Participants must comply with all instructions and guidelines provided by the trainer.

4. Liability and Assumption of Risk:
 - a. Participants understand that dog training involves physical activity and potential risks. By enrolling in the Class, participants assume full responsibility for any injuries or damages caused by themselves or their dogs during the Class.
 - b. Participants agree to hold the dog training group, instructors, assistants, and facility harmless from any claims, damages, or liabilities arising from their participation in the Class.
 - c. Participants understand that dogs may exhibit unpredictable behaviors, and while every precaution will be taken to ensure safety, participation in the Class is at the Participant's own risk.
 - d. Participants agree to assume all responsibility for any injuries, damages, or losses incurred as a result of their actions or their dog's behavior during the Class.
 - e. Participants are responsible for any damages caused by their dog to property, other dogs, or individuals attending the Class.

5. Cancellations, Transfers & Refunds:
 - a. Participants must provide a minimum of 1 week's notice if they wish to cancel their enrollment in the Class. A full refund will be issued if the cancellation notice is received within this timeframe.
 - b. Cancellation requests received less than a week before the class will be refunded half of the class fee.
 - c. Cancellation requests received less than 48 hours before the Class or failure to attend without prior notice will not be eligible for a refund.
 - d. Participants understand that the class is non-transferable to any other service or product.

6. Intellectual Property:
 - a. All training materials, handouts, and resources provided during the Class are the intellectual property of the training organization and may not be reproduced, distributed, or shared without explicit permission.

7. Class Changes or Cancellations:
 - a. The training organization reserves the right to modify or cancel the Class due to unforeseen circumstances or insufficient enrollment. In such cases, Participants will be notified promptly, and any fees paid will be refunded in full.

8. Confidentiality:
 - a. Participants agree to maintain the confidentiality of any personal information or training practices shared by other Participants during the Class.

9. Photography and Video:
 - a. Participants acknowledge that the training organization may take photographs or videos during the Class for promotional and training purposes. By enrolling in the Class, Participants grant the training organization the right to use such media without compensation.

10. Governing Law:

- a. These terms and conditions shall be governed by and interpreted in accordance with the laws of Nevada. Any disputes arising from or in connection with the Class shall be subject to the exclusive jurisdiction of the courts of Nevada.
